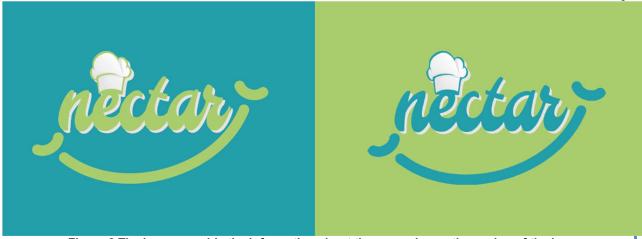


Figure 2 The image provide the information about the monochromatic version of the logo.

4 LOGO DIMENSION

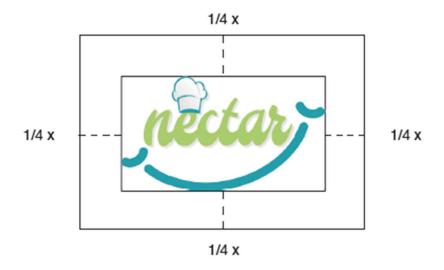
4.1 MINIMUN AND MAXIMUN

The proportion between the weight and height of the logo must be kept fixed to avoid logo deformation. The minimum dimension of the weight is fixed to 12 mm to guarantee readability. No limitation is necessary for the maximum dimension.



4.2 PROTECTION ZONE

We kindly suggest keeping a protection zone around the logo that should be set to a minimum of ½ of the logo dimension.
